Traveling by motor coach, our first stop will be "Tamarak", Beckley, West Virginia, a unique travel plaza designed to showcase the best arts and crafts of West Virginia. After a lunch at a restaurant operated by the Greenbriar, there will be time to browse the many galleries

In the afternoon the group travels to Charleston, West Virginia for a private VIP tour of the Governor's Mansion, an Italianate gem.

Continuing to our first overnight destination, we will enjoy the splendid Waterfront Place Hotel in Morgantown, West Virginia. Dinner in the hotel's "Regatta Bar and Grille is included in the package.

On Saturday morning, the group continues to Mill Run, PA to experience Frank Lloyd Wright's iconic architectural masterpiece, "Fallingwater" where a guided tour has been arranged. We will have time to lunch in the café and visit the bookstore/gift shop and enjoy the grounds.

An afternoon drive through beautiful rolling countryside brings our tour to the charming colonial town of Winchester, Virginia. After checking into the beautifully restored George Washington Hotel, a Wyndam historic property, you are free to explore Winchester. Dinner is on your own in the up-scale hotel restaurant "The Dancing Goat" or one of many downtown eateries.

On Sunday morning the tour travels to Thomas Jefferson's neo-classic masterpiece, "Monticello" near Charlottesville, Virginia. Our group will enjoy a tour of the house, and then visits to the gardens and the grounds, including "Mulberry Row", the living and working quarters of the plantation slaves. Enjoy lunch in the new visitor's center and spend time in the impressive museum shop. Monticello is one of a few "World Heritage Sites" in the United States. Leaving late afternoon we arrive back in Winston-Salem in the early evening.
